**GENERAL NOTES**

- The bearings shown hereon are referenced to the centerline of East Ocean Pearl Lane having a bearing of N73°02'56"E, according to the plat of OCEAN PEARL SUBDIVISION, as recorded in Plat Book 13, Page 57-A, Public records, Indian River County, Florida.
- All above ground fixed improvements, if any, have been located and shown hereon.
- Underground utilities and utility services have not been located on this survey.
- Flood Note: By graphic plotting only, this property is in Zones "X" and "VE", according to the Flood Insurance Rate Map, Community Panel No. 12061C0091 E, effective date May 4, 1989. The exact designation can only be determined by an elevation certificate.
- Reproductions of this map are not valid without the signature and original raised seal of a Florida Licensed Surveyor & Mapper.
- Lands shown hereon were not abstracted by this office for rights-of-way, easements of record, ownership, abandonment's deed restrictions, or Murphy Act Deeds.
- Additions or deletions to survey maps or reports by other than the signing party or parties is prohibited without written consent of the signing party or parties.
- Information shown hereon is based on platted and field measured data.
- The last date of field work was March 18, 2004.
- Elevations hereon are in feet and refer to N.G.V.D. 1929 datum. The source benchmark is the top of concrete monument and brass disc DNR 86-XB-A15.
- The Coastal Construction Control Lines (C.C.C.L.) shown hereon are based on the plat of record for OCEAN PEARL SUBDIVISION which this boundary is a part of.
- Coordinates shown hereon are based on Florida East Zone of the State of Florida Plane Coordinate System (NAD 1927) according to the plat of Indian River County Coastal Construction Control Line as recorded in Plat Book 12, Page 32 of the Public Records of Indian River County, Florida.
- Line of Construction was established from the easterly limits of the existing buildings at the Sea Colony Condominium and the Carlton Condominium.

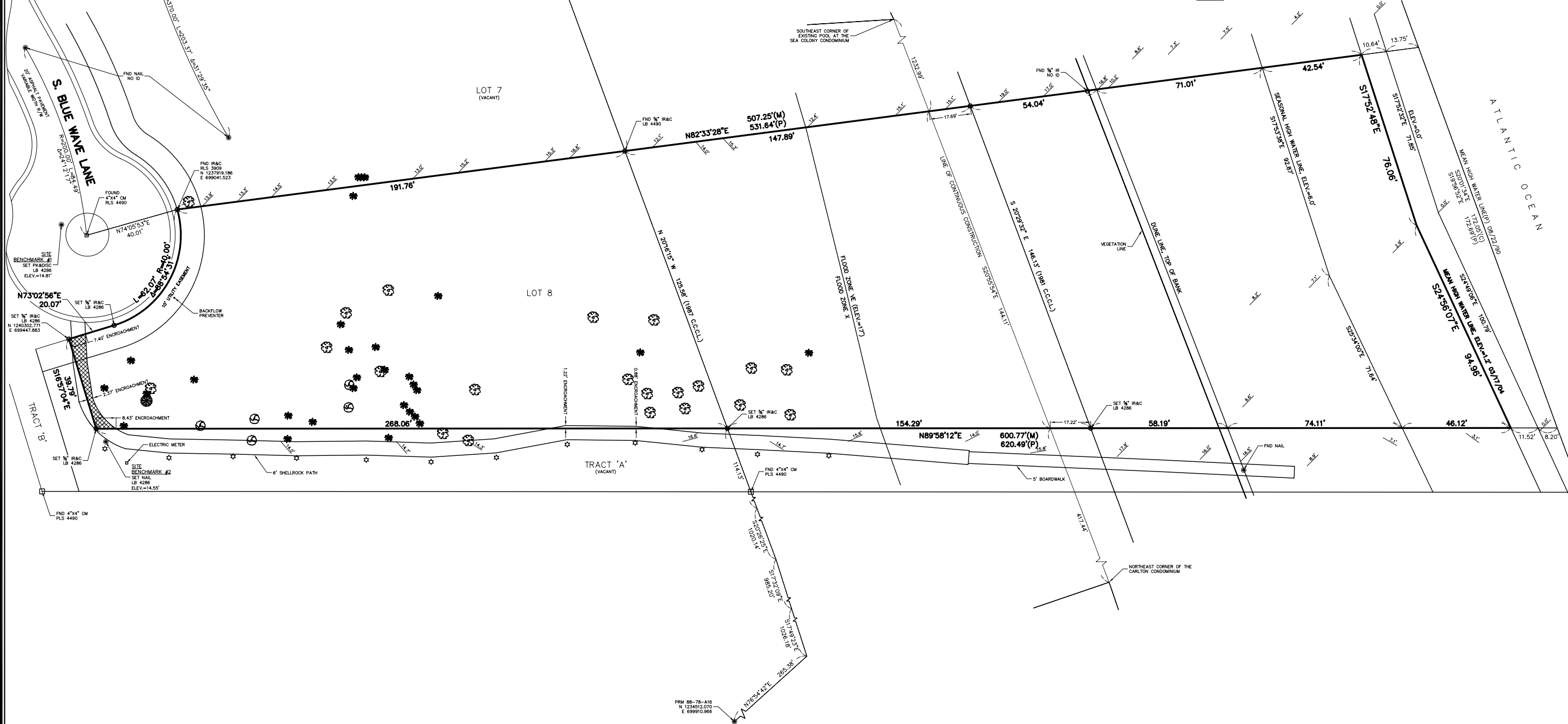
